Attached is the information you require. Clearly it needs some perspective to help aet it into context.

BACKGROUND

To begin with, The Scottish Humanists was set up in response to the HSS which was turning into a business. Having been a life member of the HSS since the midnineties, during which I spent some time on the Executive Committee helping to shape the rules, it became clear that long standing Humanist principles were being sacrificed to greed and selfishness. For example, it was the practice that members would receive a humanist funeral ceremony without payment, although invariably some payment was paid to the celebrant at the family's discretion. However, understandably, funeral directors preferred that we quote a price that could be passed on to customers looking to use our services who were not members. The price around that time was about 35 pounds to cover expenses. The Scottish Humanists was set up to get-back to the original humanism for which it was established. When a new crop of celebrants were recruited from outside the first thing they did was rescind the rule not to charge members for funeral services. It was from that point I witnessed greed and selfishness I could no longer condone as a humanist and eventually declared I would not be charging the prices being demanded. The result was, astonishingly, a few hate mails from fellow celebrants and I was subsequently stripped of my life membership of the HSS. This should explain the leaflet 'Our Scottish Humanists Humanism', a copy is enclosed, and which is read out at all marriage ceremonies and is a precis of our particular brand of humanist philosophy. It is important to note that our humanism does not owe people a living neither should lack of money prevent people becoming members of our organization which is why we don't charge for membership - humanism belongs to everyone.

CONSTITUTION

Copy attached. The constitution reflects our humanist philosophy to the extent that it is not dogmatic since we believe that humanism is an individual choice. We do not, for example, recruit children under the age of 16 years old. There is no proselytizing; we tend to attract adults by example. It has to be borne in mind that, as a humanist body, we do not organize ourselves around religious practices. It is not, as is sometimes assumed, religion without gods.

Attached to the constitution is a copy of the International Humanist and Ethical Union declaration which forms the basis of our general beliefs. However we, I hope, interpret the declaration at the local community and individual level. In recent times we have had poor attendances at meetings because of a lack of publicizing though newspapers and e-mail lists. This has been because of the substantial increase in advertising costs and various other factors. We now produce notices of meetings through advertising in supermarkets, shops, Facebook, hospitals and other outlets. However, the 2018 AGM did not take place because of

November 2017 until autumn of 2018 when was considered to be fully recovered During this period no one was prepared to stand in as Convenor although help was available. It was the other trustee, Mary Hill, who organized matters when required. This was because at a previous meeting it was agreed that the constitution should be amended so that, in an emergency, the trustees could take overall responsibility for running things which fits in with our charity status regulations.

MARRIAGE CEREMONIES

A copy of one of our marriage ceremonies is attached. You will note that I have highlighted in yellow, the precis of our humanist philosophy. This is, we think, a major means of publicizing our humanist philosophy since it is repeated at every wedding ceremony we conduct. Also shown, in orange highlight, the form of oath included in the ceremony which was agreed with your office some years ago. I have also included comments by the participants in this particular marriage as an indication of the esteem in which our marriage ceremonies are held.

We have three main marriage ceremonies consisting of a 'Candle Lighting' ceremony, which is common, a 'Hand fasting' Ceremony which is quite popular and a 'Sands of Time' ceremony where different colours of sand are in two containers to represent each partner and, after the declaration of the joining of the partners is made, the sand is poured into a third container to indicate the subsuming of each partner's personality into their marriage.

Also attached is a copy of the code of practice which indicates the high standards we expect of our marriage officers and which also indicates our humanist philosophy in respect of ceremonies and general conduct.

MEMBERSHIP

Our fiscal year goes from the first day in March until the last day of February so the last current membership is 1110 but trying to sort out local and the rest is proving difficult, as you can imagine. We have settled on our local area as being a 30 mile radius of Ayr. Which is why we also settled on 'first 60 miles is free' in our costing for ceremonies officer's expenses. So our best guess is that our local membership is in the region of 460.

We have members in Tasmania, Australia, Canada, USA and Mexico. If the man from Tasmania turns up at one of our meetings someday I will be over the moon but we won't be paying his expenses.

MEETINGS

Are held as per the constitution. Once again, it is up to the trustees to call additional meeting if they think it is needed. We have used various venues however, attendance is poor and we are now considering using The Market Inn in Ayr as a semi-permanent venue. We are also considering meeting in the surrounding area to include Irvine, Kilmarnock, Cumnock, etc. Minutes of meetings are attached.

OTHER CONSIDERATIONS

In addition to the services mentioned in this letter, The Scottish Humanists also provide grief support where possible. Myself and Alex McGrindle, who has been CRUSE trained, help out when required. However, although I hold a BSc (Hons) Psychology degree, if I am called upon to deal with a client who might have problems with which I have difficulty in coping, then I will refer them to a full time grief counsellor in one of the hospitals. To help people with grief to take the next step in their life, we purchased a block membership of the local jazz club so that they could get back into going out and socializing. After two years we have abandoned it. We also give a substantial amount to our local food bank both through pure own funds and privately. We encourage our members to contribute to the food banks either through us or the local supermarkets. We also have a large stock of books including many children's books which were destined to be sent to The Sri Lanka Rationalist Association for their schools. However, having spent two months there with my wife working with Save the Children, we discovered that the cost of delivery was prohibitive so the original idea was abandoned. We find that supplying children's books to our local food bank is an excellent way of distributing them to people who couldn't otherwise afford books. We are looking at the possibility of providing science books to our local primary schools.


We encourage our membership to help out in local hospitals by becoming a hospital volunteer.



MARRIAGE SERVICE IN ENGLAND AND WALES

Both parties must give at least 15 working days' notice to the Registrar and arrange with him/her and with the Church officials the date and time of the Marriage Service.

The Registrar or the Deputy must be present at the service unless the Church has taken steps to secure the appointment of a person specially authorised to act in the place of the Registrar.

Couples who do not live in the area of a Spiritualist Church may be married in the Church which they normally attend or their nearest Spiritualist Church. Notice of registration must be given both to their local Registrar and to the Registrar serving within the area of the Church where the marriage is to take place.

As we meet here in the presence of God with our family and friends, both seen and unseen, to share this day of joy where (name) and (name) have chosen to enter into the sacred bonds of marriage, we would impress upon them the mystic significance of the marriage tie and seek the blessing of God upon their union.

Marriage involves the most tender and lasting ties that can unite (name) and (name) in this life, for they have become so sure of their love that they will commit themselves each to the other in the name of God.

The Minister invites the guests to sit and unite in prayer.

Father God, we come together in Your presence to give thanks for all the blessings we receive. Traditionally, men and women have entered into the sacred bonds of marriage to pledge their allegiance to each other in Your presence. As we meet to witness the commitment of (name) and (name), we ask for the blessing of Your love and the companionship of our friends from the spirit world.

May strength and inspiration be given to us all now and in the future but in particular to this couple, who are here to pledge their lives together. We ask that the sincerity of the vows taken today be recorded in the higher realms of life. Amen.

As Spiritualists we know that love survives death, and that same love unites us in the world of spirit so that those who love each other may be together in eternity. Therefore this union is

even more special in that we recognise that it is made on earth and may be fulfilled in eternal life together.

As you may know, Spiritualists are not tied to any creed or dogma. We accept the Seven Principles as our guidelines for a way of life. These Principles form the core of our religion. They are the legally accepted and lawfully recognised definition of the religious philosophy of Spiritualism.

The Minister reads the Principles or invites a chosen person (e.g. the best man) to read them.

- 1. The Fatherhood of God
- 2. The Brotherhood of Man
- 3. The Communion of Spirits and the Ministry of Angels
- 4. The Continuous Existence of the Human Soul
- 5. Personal Responsibility
- 6. Compensation and Retribution Hereafter for all the Good and Evil Deeds done on Earth
- 7. Eternal Progress Open to every Human Soul

The Minister continues:

This outward ceremony can only be the symbol of the inner commitment between two hearts and two minds, which the Church may bless and the state make legal, but, to be happy, there must be a dedication of each to the other, and of both to the highest ideals of life.

Minister to all:

If anyone can show just cause or impediment why these two may not be joined together in marriage, let them now declare it or else hereafter forever hold their peace.

Minister to pause for a short while.

The Minister turns to the bride and bridegroom.

I require and charge you both, remembering your responsibility to God and spirit, that if either of you know of any impediment why you may not be lawfully joined together in marriage, you shall now declare it.

Bridegroom to repeat the Declaratory Vows after the Minister (full names to be used):

I do solemnly declare that I know not of any lawful impediment why I, (full name of bridegroom), may not be joined in matrimony to (full name of bride).

Bride to repeat after the Minister:

I do solemnly declare that I know not of any lawful impediment why I, (full name of bride), may not be joined in matrimony to (full name of bridegroom).

Alternative Choice of Declaratory Words 1:

Bridegroom:

I declare that I know of no legal reason why I, (full name of bridegroom), may not be joined in marriage to (full name of bride).

Bride.

I declare that I know of no legal reason why I, (full name of bride), may not be joined in marriage to (full name of bridegroom).

Alternative Choice of Declaratory Words 2:

Minister to ask:

Are you, (full name of bridegroom), free lawfully to marry (full name of bride)?

The bridegroom answers:

I am.

Minister to ask:

Are you, (full name of bride), free lawfully to marry (full name of bridegroom)?

The bride answers:

I am.

The Minister then asks:

Who acts as sponsor to (name of bride)?

Other appropriate words may be used.

[The sponsor could be the father or mother of the bride or any other person she has chosen to undertake this role.]

The sponsor answers:

I do.

The Minister will then thank the sponsor with a few appropriate words such as: On behalf of (name of bride) I thank you for your support. You may now take your seat.

The Minister turns to the bride and bridegroom and asks them to face one another.

Minister to the bridegroom:

In joining with (name of bride) in marriage and bearing in mind our Principle of Personal Responsibility will you love her, honour her and support her in all the joys and adversities which you may encounter and be faithful to her throughout your married life?

The bridegroom answers:

I will.

Minister to the bride:

In joining with (name of bridegroom) in marriage and bearing in mind our Principle of Personal Responsibility will you love him, honour him and support him in all the joys and adversities which you may encounter and be faithful to him throughout your married life?

The bride answers:

I will.

Minister to the couple:

What pledge(s) do you offer to fulfil these vows?

Reply:

This ring or These rings.

The Minister takes the rings from the bridegroom's sponsor [best man] and places them on to his book or a special cushion.

At this point the Minister would thank the bridegroom's sponsor [best man] with some appropriate words.

Holding the rings firmly, the Minister says:

Gold has always been regarded as a precious metal and your rings, being symbolic of an eternal circle, indicate a token of oneness, continuity and completeness and are the outward signification of the unity of your hearts and minds.

Minister to bride:

Will you now please accept (name of bridegroom)'s ring as a token and pledge of his love as he places it upon the third finger of your left hand?

The bride answers:

I will.

Minister to bridegroom:

Will you now please accept (name of bride)'s ring as a token and pledge of her love as she places it upon the third finger of your left hand?

The bridegroom answers:

I will.

Option 2:

Minister to bridegroom:

As you place this ring on the third finger of (name of bride) will you now declare your love for her. Please repeat after me:

I, (name of bridegroom), place this ring on the third finger of your left hand as an eternal and everlasting symbol of my love for you; for as long as you wear it we are as one.

Minister to bride:

As you place this ring on the third finger of (name of bridegroom) will you now declare your love for him. Please repeat after me:

I, (name of bride), place this ring on the third finger of your left hand as an eternal and everlasting symbol of my love for you; for as long as you wear it we are as one.

The Minister says to both:

With your right hands joined and your hearts open to each other, will you declare your marriage each to the other?

Bridegroom to repeat after the Minister:

I call upon these persons here present to witness that I, (full name of bridegroom), do take thee, (full name of bride), to be my lawful wedded wife.

Bride to repeat after the Minister:

I call upon these persons here present to witness that I, (full name of bride), do take thee, (full name of bridegroom), to be my lawful wedded husband.

Alternative Contract Words 1:

Bridegroom:

I, (full name of bridegroom), take you, (full name of bride), to be my wedded wife.

Bride:

I. (full name of bride) take you, (full name of bridegroom), to be my wedded husband.

Alternative Contract Words 2:

Bridegroom:

I, (full name of bridegroom), take thee, (full name of bride), to be my wedded wife.

Bride:

I, (full name of bride), take thee, (full name of bridegroom), to be my wedded husband.

The Minister, taking their joined hands between his/her own, says:

(Name) and (name) have today pledged themselves each to the other before God and in the presence of witnesses, both seen and unseen. In accordance with the powers conferred upon me by the Spiritualists' National Union it is my pleasure and duty to pronounce them husband and wife, Mr and Mrs (surname). You may now share the first kiss of your married life together.
