1. Main Points

The key points in this publication are:

Number of Households

The number of households in Scotland has been increasing steadily, by between 11,000 and 23,000 each year since 1991. Over the last year, there has been an increase of 20,000 households (just under one per cent). This takes the total to 2.3 million households in Scotland in 2006. [Table 1]

The increase in the number of households is mainly due to an increase in the number of dwellings (up by 19,000). The number of vacant dwellings and second homes has fallen (down by 290), as more of the existing housing stock is occupied. [Table 2 and Table 3]

Local Authority Areas

In every local authority area, the number of households has remained constant or increased over the last year, and over the last five years. The areas with the greatest increases over the last five years have been Aberdeenshire (8.7 per cent), West Lothian (8 per cent), Highland (7.5 per cent) and Perth and Kinross (7.3 per cent). The areas with the smallest change were Inverclyde and West Dunbartonshire, with changes of less than one per cent over the five year period. [Table 1]

Vacant Dwellings and Second Homes

Since 2002, the number of vacant dwellings and second homes in Scotland has fallen each year. This may have been influenced by a change in Council Tax policy which gave councils discretion to reduce the Council Tax discount for second homes and long term empty properties. The trend continued between 2005 and 2006 with a small drop of 290. [Table 3]

In 2006, 101,000 dwellings in Scotland were vacant or second homes (one in every 24 dwellings). The areas with the highest proportion of vacant properties and second homes (between 7 and 13 per cent of all dwellings) are the island local authorities (Eilean Siar, Orkney and Shetland), Argyll and Bute, Highland, Dundee City and Scottish Borders. However, in all these areas the number of vacant dwellings and second homes has remained stable or dropped between 2001 and 2006. Local authority areas in the Central Belt of Scotland tend to have the lowest proportion of vacant dwellings and second homes. [Table 3 and Map 1]

The number of vacant dwellings is more likely to fluctuate between years, particularly in areas with high turnover, or large numbers of vacancies or holiday accommodation. Not all local authorities are able to provide separate figures for vacant properties and second homes, so the figures are combined in this publication.

Size of Households

Since 1991, Scotland's total population has not changed greatly. However, the number of households has continued to increase (by over 12 per cent since 1991), because the average household size is getting smaller, with more people living alone and in smaller households. [Table 5 and Chart 1]

Map 1: Percentage of Dwellings that were Vacant or Second Homes, 2006





Chart 1: Change in Household Type, 1981-2005: Scotland

2. Purpose of Household Estimates

Estimates of the number of households are mainly used for informing local authority decisions about housing need and service provision. They are also used as the denominator for other statistics, such as the percentage of households receiving benefits. Household estimates are used in the production of forward household projections for Scotland, every two years (Household Projections are available on this website).

3. Description of the Method Used

Household estimates for 2001-2006 are based on information from Council Tax billing systems. These systems contain information on each dwelling in Scotland (Table 2), and dwellings entitled to certain discounts because they are vacant or second homes (Table 3). This makes it possible to produce figures on the number of occupied dwellings in each local authority area (Table 4).

This information is provided by each council to the Scottish Executive's Local Government Finance Statistics Branch each September, on the form CTAXBASE which can be found on the Scottish Executive's website. The figures contained in Tables 1-4 are based on these figures.

The number of occupied dwellings based on Council Tax figures (Table 4) is not exactly the same as the number of households recorded in the Census, due to differences in the way that certain types of dwellings are treated. These include shared dwellings, some communal establishments, some holiday accommodation, and dwellings occupied entirely by adults who are 'disregarded' for the purpose of paying Council Tax – such as people who are severely mentally impaired. Therefore, the figures for 2001 are adjusted to the 2001 Census results, to obtain an estimate of the number of households, and the figures for the more recent years are adjusted by the same amount (Table 1). The

figures in Table 1 are also adjusted from September to June, to provide comparable figures with the estimates from 1991-2001 (see paragraph below). This means that the change in the number of occupied dwellings each year will not exactly match the change in the number of households, though the trends over time will be consistent.

Council Tax was introduced in the early 1990s, so a different source must be used to provide household estimates going back to 1991. Household estimates for 1991 to 2001 are based on population estimates (Table 1). This involves taking each year's mid-year population estimate, as published by GROS, subtracting the number of people living in communal establishments, and using information on the number of households of each type, from the 1991 and 2001 Censuses, to estimate the number of households.

Council Tax systems contain little information about the type of household, so the Scottish Household Survey is used to estimate the number of households of each type, in Scotland as a whole (Table 5 and Chart 1). The sample size of this survey is not large enough to provide reliable information on each household type in each local authority area.

A detailed description of the method and sources used can be found in the publication 'Household estimates for Scotland by local authority 1991-2004'.

4. Definitions

The following definitions are used in this publication:

- **Household**: The 2001 Census definition of a household is used one person living alone, or a group of people (not necessarily related) living at the same address with common housekeeping (that is, sharing either a living room or sitting room or at least one meal a day). This excludes people living in communal establishments.
- **Private Household Population:** The population living in private households, i.e., people not living in communal establishments. We produce <u>Population Estimates</u> which are available on our website.
- Communal Establishment: An establishment providing managed residential accommodation, such as a hospital, care home, prison, barracks or student hall of residence. 'Managed' means full-time or part-time supervision of the accommodation.
- **Dwelling**: A dwelling is a self-contained unit of accommodation, such as a house or flat. This does not include free-standing lock-ups or garages.
- Vacant Dwelling: Dwellings that are exempt from paying Council Tax because they
 are unoccupied, and dwellings entitled to a second home or long-term empty
 property discount. This includes self-catering holiday accommodation available to let
 for up to 140 days per year.
- Occupied Dwelling: All dwellings, minus those that are vacant or second homes.

⁻ There can be delays in the information on Council Tax systems being updated, which are most likely to affect the information on any discounts, such as vacancy status. This is most likely to lead to fluctuations in areas with high turnover, or high levels of vacancies or second homes.

^{3.} The percentage of dwellings recorded in Table 2.

^{4.} In 2006, Glasgow City Council Financial Services moved to a new software system for Council Tax. This has resulted in a lack of consistency between the figures on the number of dwellings entitled to discounts and exemptions for 2006, and the figures for earlier years. In order to overcome this problem, the number of discounts and exemptions in 2001-2005 were adjusted to be equal to the figures for 2006. This is in line with other available data, which show little change in the number of vacancies in Glasgow in 2001-2006.
