

POPULATION AND MIGRATION STATISTICS COMMITTEE (SCOTLAND)

2011 Census Progress

1. Attached is a copy of the draft but close to final GROS Census Test Household and Communal Establishment forms.
2. There are a number of new questions. There will probably not be room for all of them in 2011. Also GROS, NISRA and ONS will seek to harmonise their respective question sets. Nonetheless in a general way we believe that the question set reflects the concerns of Scottish policy makers and sectors of the Scottish community. Some traditional questions not on the Census Test form are missing simply to allow space to test more new questions.
3. We have held to 3 monthly updates on the web-based Census questions consultations. While keeping open the option of allowing people and organisations to contact us. We will not be offering updates until we have evaluated the Census Test Results.
4. Nonetheless, I would like feed back on the proposals on visitors and second homes. The Test paper shows what we are going to test – they reflect a stage in the thinking at ONS and I feel –given our commitments to UK harmonisation and common population bases that we must test the ONS proposals in some form.
5. I would like feed back on design issues but more importantly census users will need to consider the business case for these proposals. At this stage we have not defined our business case process for deciding between questions but I would appreciate some indication of whether there is support for the proposals on second homes and visitor information - in the context of losing other questions.
6. The current working assumption is for a 24 page 6 person, 3 pages per person form. The breaks down into:

- Page 1 Front page
 - Page 2 Household and Visitor Table 1
 - Page 3 Household Questions
 - Pages 4 and 5 Relationship Matrix
 - Pages 6 to 23 6 x 3 pages of individual questions
 - Page 24 Visitor information
7. If, on cost grounds a 5 person 20 page form were used there would not be a spare page for visitor information and rudimentary data would have to be collected from Table 1.
 8. On the Census test form there will be 4 questions on second homes. They take up about $\frac{3}{4}$ of one column, so the question is, somewhat crudely, which 4 questions from 2001 or of the new questions would you be prepared to lose?
 9. I also attach the visitor and second home questions which ONS are currently testing. In that design they are somewhat space consuming but I must emphasise these are for testing only.
 10. I feel there are problems:
 - A lot of people will be in the position of being enumerated twice and may choose to be enumerated only once. But at which address?
 - It may decrease coverage as the non-compliant may be more daunted by a complicated form and remain non-compliant;
 - It reduces the other questions the Census can carry;
 - It will confuse people about where they should be enumerated.
 11. In detail, it may not address the problem it sets out to solve. If a household have a weekend second home, they may see the city weekday home as their main residence and so we have to ask will that visitor-only weekend household be compliant at both their visitor only address and their usual resident address and will they apply the correct definitions.
 12. It gives a second chance to capture people but only if you match them, determine which address is their usual residence, and potentially move them.

13. For visitors, you only get a usual residents database if you do match and move and you haven't got a population present population base unless you exclude usual residents not present on the night. I feel the complications mount potentially to the point where the publication timetable could come under threat.
14. The current GROS proposal in this area is to recheck every dwelling from which we could expect a form. I attach the 'Placeholder' form which GROS is testing in 2006 and which will be used for every property from which a form is not returned. Effectively this gives a 100% vacant follow-up survey so there will be a complete list of properties designated as non-residential, communal or residential and then further broken down as shown on the place holder form. This would not create a link between two homes in use by the household but would provide the number of second homes in an area.
15. The last point I feel I should note is that there may be a special policy interest in identifying children of divorced parents who are counted twice.
16. I would ask therefore that the broader issues are considered too. I am sure I will not have raised all the benefits nor thought through all the pitfalls and I think the issues are too broad to introduce and expect a response from this meeting today. But I would be pleased to receive feed back on these proposals and perhaps place them on the agenda for the next PAMS and there to raise action points as appropriate

H1 How many people usually live in this household, including yourself?

What we mean by a 'household' is:

one or a group of people who have the accommodation as their *only* or *main* residence

AND (for a group)

share at least one meal a day

and/or share the living accommodation, that is, a living room or sitting room

What we mean by 'usually lives here' is:

- anyone who lives here most of the time
- anyone who works away from home or are members of the armed forces
- anyone who is away from home on Census Night who lives here most of the time

◆ Remember to count:

- students and schoolchildren who are away from home during the school, college or university term
- babies born before 7th November 2005, even if they are still in hospital
